Minutes of first meeting of the core team constituted to develop MIS for PMKSY held under the chairmanship of Horticulture Commissioner on 4th November, 2015 at 10:00 AM

The first meeting of the core team constituted to develop MIS for PMKSY was held under the chairmanship of Dr. S.K. Malhotra Horticulture Commissioner; on 4th November, 2015 at 10:00 AM in his chamber. Representative of Ministry of Water Resources, River Development and Ganga Rejuvenation did not attend the meeting. List of officers present in the meeting is annexed.

- 2. At the outset, the chairman welcomed all the participants and emphasised that the exercise of developing an integrated MIS for the scheme needed to be completed expeditiously. Ad.C. (RFS) apprised the chairman that different departments implementing different components of PMKSY have to finalise their own input formats based on the parameters decided by them to capture the data from their MIS to give one touch integrated data on the scheme under MIS.
- 3. He further informed that the DoLR has its own MIS on IWMP which could be utilised to pickup data for the integrated MIS of PMKSY with an additional parameter of command area of watershed. Shri Amit Kumar, Director (DoLR) informed that they have already started working on developing the required additional parameter within the existing MIS and ensured that the final form would be completed in few days.
- 4. Shri Rakesh Wardhan, TD, NIC informed that the input format in respect of the micro-irrigation component of PMKSY has already been developed. Similarly, Ad.C. (RFS) also informed that the input format for the other intervention component being implemented by RFS Division has also been developed. These formats were discussed at length and finalised. Since representatives of MoWR,RD&GR did not attend the meeting, their input forms could not be discussed. It was decided that they be asked to finalise their format so that the same could be taken into account.
- 5. The chairman wanted to know the minimum time by which the MIS could be hosted. Shri A.N. Mishra, Sr. Technical Director informed that efforts can be made to host MIS can by 13.11.2015 pending mandatory security audit provided that the departments/divisions concerned give an undertaking that they are ready to host MIS pending security audit. The chairman agreed to this.
- 6. Finally, it was decided that all concerned divisions/departments would immediately share their formats with one state for being filled up by relevant department in the state so as to assess the feasibility/adoptability of the format and identify changes required, if any.
- 7. Meeting ended with thanks to the chair.
