

Minutes of Meeting chaired by Principal Secretary to PM on 13.01.2016 at 3.00 pm to review the Pradhan Mantri Krishi Sinchai Yojana (PMKSY).

Principal Secretary chaired a meeting to review PMKSY. The list of participants is annexed.

- 2. After detailed deliberations the following decisions were taken:
- i. 46 identified priority projects under AIBP would be taken up in two phases. In Phase I the 23 identified projects have to be completed by March, 2017. The first phase projects are to be funded by adequate provisions in the budgetary allocation.

(Action: MoWR, DEA)

- ii. The remaining 23 priority projects are to be completed by March, 2019. It must be ensured that these are demand led and realistic projects. All the projects should also ensure that complete command area development is taken care of simultaneously.
- iii. Utilization of funds during previous years to be taken into consideration while recommending budgetary allocation.
- iv. In case of shortfall of funds for second phase projects, resources may be explored for funding through NABARD or some other means by taking States on board.

[Action: (ii) - (iv) NITI Aayog and MOWR to work out the action plan in period of one week]

v. Ministry of Water Resources to depute a team of CWC officers immediately to the States to discuss the progress of AIBP projects and submit factual report on the progress of individual projects.

(Action: MoWR)

vi. NITI Aayog to work out a simplified procedure for release of fund particularly for AIBP projects

(Action: NITI Aayog, MoWR)

vii. A clarity on action plan 2016-17 on all parameters of PMKSY be worked out with all variants like area coverage, budget required, and institutional mechanism for release of funds & monitoring of projects.

(Action: DAC&FW, MoWR, DoLR, DoRD)

viii. The progress under all components of PMKSY should clearly indicate the irrigation potential created. The information on employment generated through these interventions may also be monitored.

(Action: DAC&FW, MoWR, DOLR, DoRD)

Once the action plans by different implementing departments are worked out. The Action plan should clearly spell out District wise details.

(Action: DAC&FW)

X. Efforts be made to finalize the irrigation plans for all the districts by March, 2015. NITI Aayog should assess them and share the best plans with all stakeholders.

(Action: DAC&FW)

xi. As implementation progresses, a clear framework should be created to link additional productivity with increased irrigation. This should be reported regularly.

(Action: DAC&FW, NITI Aayog)

xii. Department of Land Resources (DoLR) and Department of Rural Development (DoRD) should strengthen their monitoring mechanism to gather specific information on irrigation potential created/area covered under drought proofing.

(Action: DoLR, DoRD)

xiii. Ministry of Water Resources should immediately make functional the web based monitoring and information system and upload the information in the MIS expeditiously.

(Action: MoWR)

xiv. All the structures created due to interventions under PMKSY be geo tagged for web based visual representation.

(Action: DAC&FW, MoWR, DoLR, DoRD)

Xv. Doordarshan/Media/Kisan Channel to be associated in assessing the impact of irrigation potential created by interviewing farmers and telecast them periodically.

(Action: DAC&FW, MoWR, DOLR, DoRD)
