Prioritization of Projects

- NITI Aayog and Ministry of Water Resources, RD&GR have jointly prioritised 46 major and medium irrigation projects for completion by 2019-20.
- These projects will create 18.62 lakh ha of irrigation potential with an investment of Centre share of about 20,000 crore.
- Out of this 23 projects have been targeted for completion in 2016-17 which will require central share of Rs. 7949 crore to create irrigation potential of 7.17 lakh ha
